

## **DRAFT WILL CLAUSES**

The Benslow Musical Instrument Loan Scheme (BMILS) is extremely grateful for all bequests.

Below are three separate suggested forms of wording for your solicitor that cover legacies that include the whole, or part of the residue of an estate, pecuniary legacies and specific legacies. Please use the wording relevant to the type of legacy you are making in your will.

## RESIDUARY LEGACY - THE RESIDUE OR PART OF AN ESTATE

I give

All/a share (please state fraction/percentage)

Of the residue of my estate to Benslow Musical Instrument Loan Scheme ("the Charity") of Benslow Lane, Hitchin, Hertfordshire SG4 9RB, Registered Charity No. 313755, absolutely, to be applied by the Charity for its charitable purposes and I direct that the receipt of the Hon Treasurer or any other proper officer for the time being of the Charity shall be a sufficient discharge to my executors. If before my death (or after it but before my Trustees have given effect to the gift) the Charity has changed its legal name or amalgamated with another body or transferred its assets to another body, my Trustees shall give effect to the gift as if it were a gift to the body in its changed name or to the body which results from the amalgamation or to which the assets have been transferred.

## PECUNIARY LEGACY
